





Mille Lacs Corporate Ventures is a corporate body politic and tribal corporation created to manage the Mille Lacs Band of Ojibwe's business affairs.

Workforce Housing

Housing shortages across the state of Minnesota, as well as in many areas of the country, have hit historic levels and show signs of worsening. While developers focus the insatiable demand for luxury housing, employers can partner with the public sector to meet their labor demands by satisfying the public's need for affordable housing supply. MLCV's commitment to supporting rural communities includes projects, like Workforce Housing, that will help spur an ecosystem for business investment.

MLCV has three multifamily residential developments; one complete, one in the construction phase, and one in the pre-construction phase.

Lady Luck Estates

Project complete: Built in 2018

28-unit, \$8.2MM townhome development financed with Housing Tax Credits.

The Mille Lacs Band contributed \$1.5MM towards an equity investment in the project.

- · 12 two-bedroom, 1.5-bath units and 16 three-bedroom, two-bath units.
- At initial lease up, the tenant mix was 50% of households employed by non-MLCV businesses, and 63% were non-Tribal.
- · Four units serve previously long-term homeless families.
- · Property taxes paid: \$18,681 in 2021 and \$19,326 in 2022.

Red Willow Estates

Under Construction

30-unit, \$14.5MM townhome development financed with Housing Tax Credits, among other sources.

The Mille Lacs Band of Ojibwe contributed \$5.2MM towards sitework and an equity investment in the project.

- 22 two-bedroom, 1.5-bath units and Eight three-bedroom, 1.5-bath units.
- · Four units serve previously long-term homeless families.
- The project began construction in the spring of 2022 and will be completed by the spring of 2023.
- Property taxes anticipated: Over \$23,000 annually upon completion of construction.

Sugar Maple Crossing

In Development

40-unit, \$16.9MM townhome development.

- 10 one-bedroom units, 20 two-bedroom units, and 10 three-bedroom units.
- This is an affordable market-rate housing development and will target working middle-class families.



Lady Luck Estates is the first new multi-family affordable housing built in Hinckley in 30 years.



About the Mille Lacs Band of Ojibwe

Five hundred years ago, the ancestors of the Mille Lacs Band began migrating west from the Atlantic coast of North America. By the mid-1700s, the Oiibwe had established themselves in the region around Mille Lacs Lake in what is today East Central Minnesota. The Mille Lacs Reservation is home to the Non-Removable Mille Lacs Band of Ojibwe. It was established by the Treaty of 1855, which set aside 61,000 acres as the Band's Reservation on and around the south end of Mille Lacs Lake.

The Mille Lacs Reservation consists of three districts. The Twin Cities area is also home to several hundred Mille Lacs Band members. There are more than 4,700 enrolled Mille Lacs Band members.


About Mille Lacs Corporate Ventures




Businesses within the Mille Lacs Corporate Ventures portfolio.

To increase the quality of life in the community, MLCV, Mille Lacs Band of Ojibwe, Pine County, and the City of Hinckley are currently studying the feasibility of an \$18MM infrastructure project. The project includes improving access to Hinckley area businesses via a new Hincklev traffic corridor, a new Tribal Economy business park, and a trailhead for the Willard Munger State Trail. Generating over 2,493 new jobs and over \$159MM in new labor income to northern Pine County, these improvements are also targeted to recruit even more investment in the area.
